# ACADEMY IN COOPERATIVE EXCELLENCE PROGRAM GEARS UP FOR A SECOND YEAR

At the end of the month, TACC staff along with speakers, and emerging leaders will gather at the Inn on Barons Creek in Fredericksburg for the Texas Academy in Cooperative Excellence Program. This is a three-day conference focused on connecting the dots with the newer generation of farm families and co-op leaders by introducing them to alternative business structures, with a special emphasis on the famer-owned business model. The theme of this conference, "Farmer Ownership: It Comes with Responsibilities and Commitment," will set the tone for the development of not only the speaker line up, but the delivery methods as well.

Notable speakers on the program include: a South Texas and West Texas co-op board president, a co-op CPA, professors, co-op attorney, a banker, economist, co-op CEO's, and a trade association representative. If you wish to enroll a couple or have questions about the school, call our office.

#### **NEW FARM STORE SUMMIT SET FOR FREDERICKSBURG**

What started as a routine field contact swing to South Texas co-ops a number of weeks ago, has now blossomed into a full – blown collective effort to host a "Farm Store Summit" in an initial attempt to restore greater profitability to farm supply operations. Subsequently, more calls were made to central and west Texas stores to gauge the feasibility of such an event. EVERYONE was encouraged by the concept! To date, 38 people are registered!

Based on a very successful initial roundtable held on this subject a few weeks ago, we developed the two half – day agenda. Basically, the first day will allow each co-op to share their challenges and how they conduct their respective farm store operations (and allow participants to ask questions), followed by dinner — which is where many private conversations will occur. The next day, is loaded with talent outside the co-op culture and some successful businessmen, which should offer participants alternative ways of doing business. These speakers include a representative from HEB grocery stores, a regional hardware vendor supplier and a respected co-op manager successful at running a farm supply store. We will conclude the meeting by recapping the two - day event, and with Gary McLaren's legal help, determine the proper direction in the future.

#### **JOINT COOPERATIVE MEETING**

TACC's annual Joint Cooperative Meeting will be held March 15-17 in The Woodlands, Texas at The Woodlands Resort. This year's theme, "Co-ops: Providing the Mechanism to Move Agriculture," captures how cooperatives can restore profitability and a confidence in agriculture! The very nature of the co-op business structure---farmer-owned, farmer-directed, a shared-recipient of margins---gives members a powerful advantage in a risky sector of the economy.

Keynotes include a well-known advocate for farmers, a noted ag economist, and a high-flying Navy Seal with expertise in leadership in high-risk, high-consequence environments. Breakout sessions cover labor, legal, and tax issues facing co-ops, and a debut of TACC's results from our 2019 Compensation Study.

#### SUPPORT YOUR TACC-PAC DURING FUNDRAISER FEBRUARY

TACC-PAC will be heading up a new campaign in February to raise funds in support of PAC activities and your representation in Austin. People join cooperatives largely because there is power in numbers --- bargaining power. The same can be said of electing good people. The very nature of the cooperative structure, makes it an effective tool for government policy action! As such, years ago, TACC - PAC (political action committee), began a new process to recruit dollars to aid those in campaign elections who speak the farming and ranching language.

They did it by establishing the Charlie Award for those co-ops whereby each director in a co-op & the general manager gave a minimum of \$100 annually & the total came to at least \$1,000. They also created the 100% Club for those co-ops whereby the same group of farmers annually gave \$25 each. For those who believe in the process to elect people understanding ag, but are not on the board of a co-op, they can contribute \$100 individually to the group known as "Capitol Solos".

Today, more co-ops want to further that process, but just don't know how. Giving so little to something so immediate, can make a huge impact or said another way, contributing politically in a small way when combined with others can move mountains.
