

## Heavy Dose of *Recruiting* and *Preserving* Labor to Highlight Ruidoso Co-op Managers Meeting

A group of 22 co-op and industry leaders met during the April 5 Texas Cotton Ginners Association Gin Show in Lubbock and drafted what they felt would be the ideal body of work for the July 11 - 13, 2018 TACC Co-op Manager / Director Conference at the Inn of the Mountain Gods Resort in Ruidoso, NM. (575-464-7012). The result --- remarkably and uncharacteristically, 10 of the 11 speakers were confirmed within the first week. A dynamite program awaits co-op general managers, associate members and, for some, those who also hold their annual family reunions. It is common for 140 people to attend the meeting.

Although formal invitations have not yet been sent, TACC is holding a block of rooms at the special rate of \$129.99, with a cut-off date of June 10th. There will also be a \$15 resort fee / night.

The event begins with a lunch at Noon, July 11, followed by an afternoon program and evening reception, a Thursday and Friday morning program --- complete with the traditional golf (\$85) AND washer pitching tournament Thursday afternoon. The registration fee will be \$375.

A big feature of the program will be to attack co-op labor issues head - on. To accomplish this, three outside resources and three different approaches will be used; including the #2 person at a 9 staff - member cooperative that solicits and coordinates labor needs from around the world and have been doing so since 1989, a representative of a regional sugar co-op in the Rio Grande Valley that actually trains OSHA inspectors, two representatives with a great track record at South Plains College in Levelland at recruiting ag workers into the workforce, AND the highly - popular **Michael Daggs**, returning again this year to address the much - requested topic of personality types and getting along with various generations of employees in the workforce.

Several other speakers will include the head of the national co-op trade association in Washington, D. C., who was the point person on all the Section 199 tax controversy, chief economist for the National Cotton Council, **Gary McLaren** and **Gail Faries** with their traditional law and tax review, and Texas Tech with a look at how directors value their role in co-ops.

Conference theme will be "Co-ops: Ground Zero for Farmer Action". As the Council does every other year, a **TACC Cooperative New Managers conference for new managers AND new mid - managers hired or promoted within the last two years, will be held the morning of Wednesday, July 11.**

Although not yet confirmed, one of the more surprising speakers could well be a "financial planner" to address issues for the young and the old and will cover such topics as how to ask the right questions regarding retirement AND there is a way to apply for social security and there is a way not to apply for it. It may surprise you!

For the 19th consecutive year, the Council has published a book that has been much more than a co-op directory. It's also a great resource guide. The next version will be mailed the week of May 14 to all members. For ease of use, this edition can again also be found on the Council's app and website. It contains contact information on all ag, electric, telephone and farm credit co-ops in the state AND has the information cross-referenced three ways: by city, by managers last name, and by type of co-op.

The 158 – page document also has a section on “Co-op 101”, history of co-ops, and state and federal agencies / trade associations that impact cooperatives.



## TACC Facebook Posts Still Hitting a *Nerve*

In recent times, TACC has been one of the ag associations leading the way in use of social media and technology trends. In fact, the Council has posted at least one topic each day on Facebook since December 1, 2016 and introduced its app on March 1, 2017. If you go back in the day, the Council was the 4th ag trade association in the state to launch an e-mail newsletter concept and that was in 2004.

For 2018, the biggest attraction on Facebook occurred on March 12 when 5,160 people were reached regarding TACCs three Distinguished Service Award winners of **Johnny Anderson**, **Darwin Robertson**, and **Bob Stanley**. It also received 48 likes and 15 shares. The next biggest draw occurred on January 26th when it was announced that **Aaron Herring**, a former TACC Co-op Summer intern from Tarleton State had been hired at the co-op in Knippa. That post received 1,948 views, 60 likes, and 18 comments.



The most “likes” occurred on April 6th when TACC reported that Central Rolling Plains Co-op General Manager **Larry Black** in Roscoe was elected president of the Texas Cotton Ginners Association. He received 64 likes and it reached 1,056 people.

According to TACC Manager of Marketing and Communications, **Whitney Curry**, the Council's Facebook seems to be most active on Tuesday and Thursday.

## TACC to Formalize and *Expand* an Existing Service

During the August 2016 TACC Executive Committee strategic planning retreat to Marble Falls, one of the recommendations that surfaced, to the approval of all, was for the Council's staff to realign its offerings to include more services that assist cooperatives in better connecting / communicating with all generational groups within the membership, improving customer service, implementing growth strategies, taking greater advantage of annual meeting opportunities, growing and retaining the co-op membership, and properly addressing training needs.

To this end, TACC launched late last year a concept whereby the staff will make itself available to **conduct on-site marketing audits and assessments with the co-op CEO and mid-managers**, then several weeks later returning with its blueprint or recommendations for improvement. Given the varied communication and training backgrounds of TACC staff, the Council would also be in a position to assist organizations in carrying out some of the recommended projects.

TACCs **Tommy Engelke** says of the new venture, “You might say that with all the strategic plans we have facilitated for co-ops, economic footprint placemats prepared, and on-site training directives completed, this concept basically formalizes and galvanizes our work to another level. That was a great boost knowing that our leadership group felt so confident in us and our abilities that now they want us to expand the delivery system. We're all for it!”

## State Co-op PAC *Active* in Recent March 6 / May 22 Primary Election

A political action committee usually exists because an industry segment wants to have access or influence in electing individuals who speak and represent their language. For ag, that is becoming a much more demanding task as population shifts to the cities continues; especially in a state like Texas. There are about 15 “ag” PACs in Texas and TACC created theirs in the late 1970s, when general manager of then Stamford Electric Cooperative (*in Stamford, Texas*) **Charlie Stenholm** decided to run for U. S. Congress. The rest is history!

Recently, TACC – PAC made \$19,050 in contributions to the March 6 and May 22 primary and runoff election in 39 of its races ----- ONLY LOSING ONE RACE!

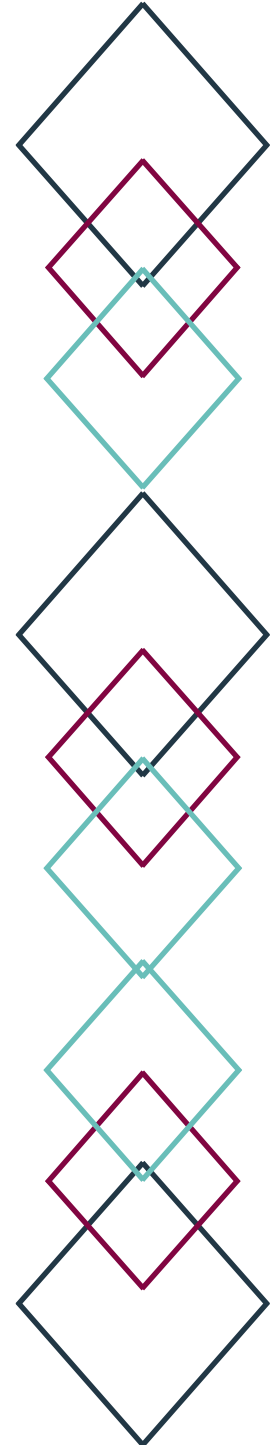
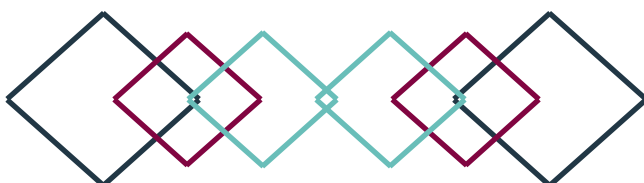

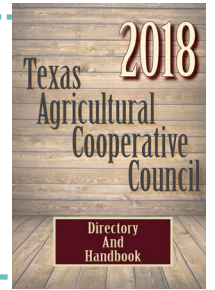

There are about 15 “ag” PACs in Texas and TACC created theirs in the late 1970s, when general manager of then Stamford Electric Cooperative (*in Stamford, Texas*) **Charlie Stenholm** decided to run for U. S. Congress. The rest is history!

Recently, TACC – PAC made \$19,050 in contributions to the March 6 and May 22 primary and runoff election in 39 of its races ----- ONLY LOSING ONE RACE!

The next TACC – PAC activity will occur for the November 6, 2018 General Election.

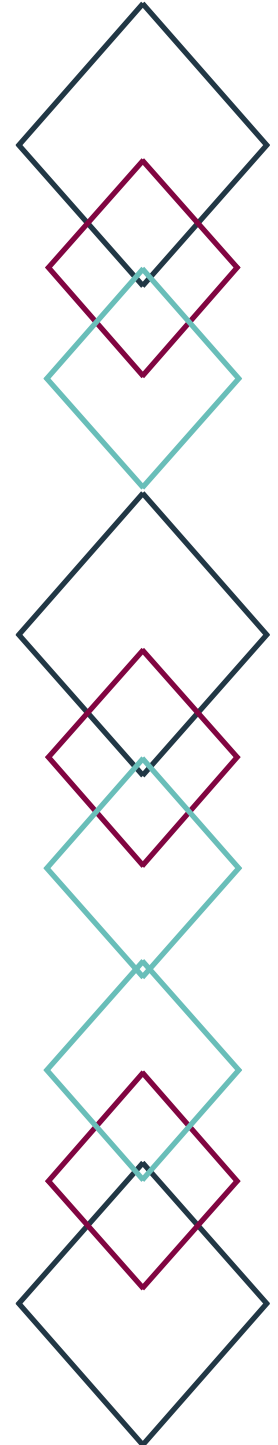
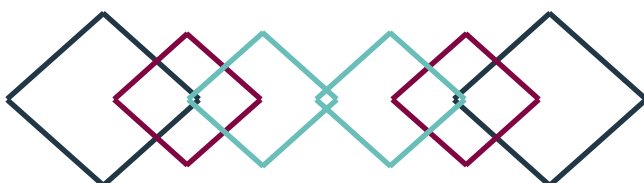
